Does It Add Up? Examining How Counties Spend Their Dollars

Introduction

Local budgets play a critical role in the health and wellbeing of communities of color. County budgets fund many public services and programs that impact broader social determinants of health such as public assistance programs, local law enforcement, and parks and recreation (Advancement Project, 2021). Along with state and federal funding, county budgets fund the local health and social safety nets that many people rely on in their everyday lives, such as mental and behavioral health and public health departments.

In partnership with the CSU East Bay Department of Public Health, this brief analyzes the county budgets of five large counties — San Diego, Kern, Fresno, Orange, and Sacramento — to compare how county budgets were spending on public health and mental/behavioral health services, versus other parts of the county budget such as law enforcement and Sheriff's Departments. We focus specifically on the county budget because of its responsibility towards the Department of Public Health, mental and behavioral health services, and the Sheriff's Department.

This brief is a continuation of our previous research:

- <u>At What Cost</u>: Our report which analyzes public health spending data and law enforcement spending before the pandemic and how such spending disparities affected the health and wellbeing of communities of color. We found that local and county law enforcement spending in 2018 totaled \$25 billion, while public health funding was only allocated \$3.7 billion. These disparities are much greater due to the increased spending for city police budgets.
- <u>People Power for Public Health</u>: Our flagship report that focuses on the selected five key counties and gathered listening session data around the health and wellbeing of communities of color.

We identified broad spending trends found in these counties' budgets for fiscal year 2021 - 2022.

- How much the county pays for law enforcement and health services
- How much mental and behavioral health services, public health departments, and sheriff departments receive from the county
- How much the county spends per resident for each department

A Local Budget Glossary

County General Fund: The County's main operating fund. The General Fund is used to account for all of the County's financial resources, except those required to be accounted for in another fund. For advocates, this is the most flexible part of the county budget and is important to look at for budget demands.

Net County Cost: Net County Cost is the amount a county allocates from its General Fund to a program, service, or department after accounting for other guaranteed local, state, and/or federal revenues. This is also referred to as the General Fund allocation.

Total Appropriation: This is the total amount a department or fund is permitted to spend. This includes not only funds from the general fund, but also state and federal taxes among other sources.

General Flows of Funding

There are various taxes and revenue used to pay for health services and law enforcement. These funding sources are crucial to understanding net county costs and fluctuations in county budgets.

We recommend that advocates and policymakers do more in-depth research of the various taxes and revenue that support these departmental services.

Some Things to Note

Counties Define Public Health & Law Enforcement Differently: Each county defines law enforcement & health services in different names such as public protection or justice services for law enforcement or human services or community services for health services. Within the categories of public health and law enforcement, counties will also group departments differently within each category. For instance, San Diego's Public Safety budget includes the Office of Emergency services while Fresno's Justice Services does not. Relatedly, Sacramento does not report a public safety section. With health services, counties may group health services with other services such as animal services or housing development, as seen with Orange and San Diego's budgets respectively. As a result, counties cannot be compared accurately due to these different groupings. For the sake of this report, we share the name given in the county budget for how the county distinguished each service in italics as well as what departments are included in each category.

Inconsistency in Data Sharing: Due to lack of statewide accountability processes, counties also were inconsistent in sharing data around their county budgets such as around spending around jails or even sharing their most recent adopted budget. Additionally, for law enforcement spending, some county budgets separated law enforcement services into separate departments. For instance, in Sacramento County, the Sheriff's Department was not combined with other law enforcement departments like Probation, whereas in Fresno County, the budget combined these services as "Justice Services." At the minimum, we addressed law enforcement spending in each county by noting funding for the county's Sheriff's Department, although we know law enforcement goes beyond the Sheriff.

Blurring between Law Enforcement and Health Services Budgets: We found in our analysis that there is not a clear distinction between budget allocations for law enforcement and health services. In some law enforcement budgets (see: Sheriff, Probation, etc.), we found that some of the funding was used for mental health services in the jails. Similarly, with public health spending, we found health funding given to law enforcement and carceral systems for medical and behavioral health services. We recommend further research to examine where expenditures are going within each department.

Inaccessibility to Understanding County Budgets: County budget documents are largely inaccessible, making it difficult to find the information needed. We recommend that counties not only share their most updated budgets but provide community education in helping constituents understand their local budgets for increased transparency over governmental dollars and how they are being used.

Cities Account for a Significant Portion of Law Enforcement Spending: Note that while counties are responsible for a significant portion of law enforcement spending, cities also play a significant role. Previous CP that compared to \$12.8 billion spent by counties in Fiscal Year 2018, cities spent an additional \$12.4 on their local police departments, with much of the cost coming from larger police departments serving major metropolitan areas.

Counties report expenses differently: Services may be organized differently, and counties use different methodologies to quantify their discretionary spending, especially within budget summaries. As such, it is easier to compare funding levels between functions and departments within a county, as opposed to spending between different counties.
