

### **Health Facts**<sup>1</sup>

- 887,482 (41%) of San Bernardino County residents are enrolled in Medi-Cal
- 239,811 San Bernardino County residents were enrolled through Medi-Cal Expansion
- 8% in San Bernardino County suffer from psychological distress; mental health has been identified among the top community health need
- 15% of San Bernardino County residents report their health status as fair or poor, similar to all Californians

## **Delivery of Services**

Medi-Cal enrollees receive mental health and substance use services primarily through Medi-Cal Managed Care plans (MCPs) and San Bernardino County's Mental Health Plan (MHP). San Bernardino's two MCPs and the county MHP provide Medi-Cal services through a coordinated system of care in which enrollees may receive a portion of their care from the MCP and other portions from the MHP depending upon their mental health and substance use care needs. MCPs in San Bernardino: (1) Molina Healthcare of California Partner Plan; (2) Inland Empire Health Plan.

#### Medi-Cal Managed Care Plans (MCPs)

MCPs and their subcontractors primarily deliver outpatient mental health services including:

- Outpatient individual or group therapy
- Medication management
- Psychological testing
- Outpatient supplies, labs, & medications
- Psychiatric consultation

### MCP & MHP



The MHP provides specialty services for adults meeting medical necessity criteria and children including:

County Mental Health Plan (MHP)§

- Rehabilitative mental health services
- Targeted case management
- Psychiatric inpatient hospitalization
- EPSDT, including supplemental services

In the Works:

- 8 housing developments providing nearly 765 housing units upon completion.
- The Walk in Our Shoes Campaign educating 4th-6th grade students through school plays and online engagement about individuals with mental health challenges.
  - Whole Person Care Pilot Program providing approximately 2,000 Medi-Cal enrollees with additional care coordination services.



# **Community Recommendations to Advance Equity**

CPEHN facilitated community dialogue meetings across 4 regions in Southern California in late 2016 (Los Angeles, San Diego, Ventura, and the Inland Empire) to identify recommendations.
